I understand that the Ski Area is not responsible for the consequences of its own negligence, that is, its failure to use reasonable care in any way in the operation of this rental center and tubing hill, as well as the installation, maintenance, selection, adjustment and use of this rental equipment. I acknowledge that I am freely and expressly assuming and accepting any and all risks of property damages, personal injury or death as the user of this equipment on my own behalf and on behalf of my minor children that I am responsible for, as listed above.

I UNDERSTAND AND AM AWARE THAT SNOW TUBING IS A HAZARDOUS ACTIVITY. I understand that snow tubing and the use of snow tubes involves a risk of injury to any and all parts of my or my children's body. I hereby freely and expressly assume and accept responsibility for any and all risks of injury or death while participating in this activity.

I agree to hold harmless and indemnify the Ski Area for any and all loss or damage I may cause to other persons or property while engaged in snow tubing activities. This includes, but is not limited to, any and all claims for personal injury, death and/or property damage that may arise out of my use of any equipment, regardless of whether such loss or damage is caused to me or to others.

This agreement is governed by the laws of New Hampshire and any claim brought against The Ski Area. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect. I agree that there have been no warranties, expressed or implied, which have been made to me beyond the information written on this form. I, the undersigned, acknowledge that I have read this agreement and release of liability and I understand its contents. I understand that my signature below expressly waives any rights I or my children may have to sue the Ski Area for injuries and damages.

That it is understood by you and the parent that you have given permission to sign this release form on there behalf or absents. 4. That you are aware that by signing this form that you could possibly have legal action brought against you regarding whether you have legal rights to sign this release form. If you are a person that is responsible for a group a general permission slips for this activity stating to the parent that by signing the slip they give the group organizer permission (legal authority) to sign related release form (on the parents behalf) for this activity will help guard against this type of litigation.
